### Chapter 1 – Membership

- **Section A: Qualification**
  - Membership is FREE. You must be employed as a funeral director, embalmer or employed at a funeral home, cemetery or funeral resource company to be qualified for membership.
  - A minimum event attendance fee of \$10 may be charged for some events.
  - A Funeral Diva is a Distinguished Woman that Contributes to the Creation of a Funeral Ceremony.
- **Section B: Disqualification**
  - You may be disqualified as member of the Funeral Divas if you display un-lawful or unethical practices within the funeral profession, Funeral Divas meetings and conference calls or at Funeral Divas events.

### Chapter 4 – The Leadership Team

- The Funeral Divas leadership team consists of Funeral Divas Directors and Bloggers. The Leadership Team is usually the first contact for members and the general public. The Leadership Team includes a membership director, spokeswoman, mentorship director, communications director, sales director, bloggers and the president of Funeral Divas, Inc. The leadership team also serves as the advisory board to the president of Funeral Divas.

### Chapter 5 – State Chapters

- Funeral Divas state chapters are created after your State has 10 or more members. After your state chapter is created a chapter president will be selected from the members in that chapter.

### Chapter 6 – Chapter Presidents

- Chapter presidents are in charge of hosting events, being role models to members and they serve as advisory board members to the president of Funeral Divas, Inc. There is one chapter president for each state chapter.

### Chapter 7 – Events

- One of the most important rules for maintaining your Funeral Divas membership is attending events. If you are in a state that has a chapter you must attend events. Missing three chapter events per year will cause your Funeral Diva membership to become inactive. If your membership becomes inactive you must attend three consecutive Funeral Divas events to reactivate your membership. There will be at least six Funeral Divas events in your area in one year.

### Chapter 8 - Revocation of Membership

- **Section A:** Your membership to Funeral Divas can be revoked by breaking rules stated in Chapter 2: Section B.
- Your membership to Funeral Divas can be revoked by breaking rules stated in Chapter 7.
